

## I am getting a minor in Computer Technology & Applications and need to take CS 466 – but it is no longer offered. What do I do?

Effective Spring 2014, the Computer Science Department will no longer offer CS 466. If you are minoring in Computer Technology and Applications and DegreeWorks indicates that you need CS 466 as part of this minor, you have two options:

First, Computer Science will substitute any of CS 205, 305, 345 or 385 for CS 466. Your minor would include:

- CS 102
- At least one of CS 205, 305, 345 and 385 – a substitution for CS 466
- 12 additional hours of CS courses (for a total of 18 hours), this may include one or more CS 391 classes
- Students in Arts & Sciences must also complete two of these CS classes at the 300-level or higher

Second, move to the new version of the minor (shown below) in DegreeWorks. Note: this may impact the degree requirements within your major field of study, so be sure to discuss this with your advisor.

In either situation, the student is responsible for working with his/her advisor to ensure that DegreeWorks properly recognizes the minor courses. Your advisor can make any necessary substitutions for CS 466 based on the information provided above.

### Requirements for the Computing Technology and Applications Minor (The New Version, Effective Fall 2013)

- **CS 102: Microcomputer Applications:** 3 hours.
- **Six (6) hours of CS courses that complete one of the four sequences listed below:**
  - CS 202 and CS 205 (Web)
  - CS 285 and CS 385 (Spreadsheets)
  - CS 302 and CS 305 (Databases)
  - CS 340 and CS 345 (Law and Ethics)
- **Nine (9) hours of additional courses offered by the Computer Science Department.** Most students select their nine hours courses from the list below:
  - CS 202, Introduction to the Information Highway
  - CS 205, Web Site Design
  - CS 285, Computerized Management Information Systems
  - CS 302, Computer Database Systems
  - CS 305, Advanced Database Systems
  - CS 340, Legal and Ethical Issues in Computing
  - CS 345, Advanced Legal and Ethical Issues
  - CS 385, Advanced Computerized Management Information Systems
  - CS 391, Special Topics

### Comments

- The following courses all carry a C-designation and thus can be used towards the completion of your Core Curriculum requirements:
  - **CS 202, CS 205, CS 285, CS 302, CS 305, CS 340, CS 345, CS 385**
- CS 391 special-topics courses will count towards the 18 hours for this minor. However, they do **not** carry a C-designation and thus cannot be used towards your Core Curriculum requirements.
- Students who pass the CS 102 placement test must still complete 18 hours of CS coursework.
- For students in the College of Arts & Sciences, at least two of your CS courses must be 300-level or higher.
